## **KNOW THE RISKS**

• The majority of the population recovers from COVID-19, and experiences only very mild symptoms.

- Young, healthy people have a nearzero risk of dying from COVID-19.
- COVID-19 vaccine benefits are not proven to outweigh the risks, especially for children and young, healthy adults.

• The COVID-19 vaccine has not been proven to be safe or effective. It does not prevent infection or reinfection, and so it cannot create herd immunity.

### THE MOST FREQUENTLY REPORTED COVID-19 VACCINATION REACTIONS

- Fainting (syncope)
- Blood clot(s) in the lungs
- Anaphylactic reaction
- Deep vein thrombosis
- Pneumonia
- Low blood platelet count
- Blood clot(s) or bleeding in the brain

- Cerebral stroke
- Loss of consciousness
- Myocarditis

#### PEOPLE WHO HAVE ALREADY HAD THE COVID-19 VIRUS ARE ALREADY NATURALLY IMMUNE

A Canadian study shows that the majority of unaffected adults have natural immunity to SARS-CoV-2. ## THE LEGAL FACTS

Using coercion to force people to get a medical intervention is a violation of our Canadian Charter Rights and the Nuremberg Code.

In a democratic society, vaccination must always be a choice, free from coercion.

### YOUR BODY, YOUR CHOICE

The Supreme Court of Canada has ruled that informed consent is required by law. ALL known and potential risks must be fully disclosed. Reibl v Hughes went all the way to the Supreme Court of Canada. In 1980, the Court articulated the current standard for informed consent, specifically that the physician (or other health care provider):

"...must give the patient sufficient information so that an objective, reasonable person in the patient's position would be able to make an informed choice about a medical procedure."

The court defined failure to disclose the attendant risks as negligence.\*

### MEDICAL PRIVACY IS PROTECTED BY LAW

Requiring disclosure of private medical records violates HIPPA health privacy laws. The Privacy Commissioner stated it is not warranted or justified to require COVID-19 vaccine records.\*



# **VACCINE REACTIONS**

In the first 6 months of use, the COVID-19 vaccine had 7,408 reported adverse reactions. This is only a small percentage of actual incidents, since reporting is voluntary and passive, not publicly accessible, and medical professionals are not trained on how to recognize and report vaccine reactions.\*

The average age of COVID-19 related death in Canada is 83 years old. Out of 25,942 total deaths in Canada, almost 95% were over 60.

Dr. Byram Bridle, PhD, researcher and vaccinologist, has stated that the spike protein in the COVID-19 vaccine is a pathogenic protein, a toxin that can cause damage in our body. It is almost entirely responsible for resulting damage to the cardiovascular system. This protein gets into the blood and circulates through the whole body. It binds to the receptors that are on the platelets, to the cells that line the blood vessels, and can therefore lead to clotting. This is why we are seeing heart and blood issues after vaccination.

The protein can cross the blood-brain barrier to cause neurological damage, which can result in death. It accumulates in tissues such as the spleen, liver, bone marrow, adrenal glands, and in high concentrations in the ovaries, potentially causing infertility.

Spike proteins also get transferred through breast milk. Nursing infants are now experiencing bleeding disorders after being exposed to the spike proteins via breast milk from vaccinated mothers.



# THE COERCION

Governments, corporations and schools have been given financial incentives to gain your trust in vaccines in order to promote vaccine compliance.

In 2021, the Public Health Agency of Canada created a partnership fund to "increase confidence, acceptance and uptake of COVID-19 vaccines." They paid 9 million dollars to Canadians.

• Not-for-profit organizations, associations, societies, and coalitions

• Provincial, territorial, regional, and municipal governments and agencies

Organizations and institutions supported by provincial and territorial governments (such as regional health authorities, schools, post-secondary institutions)
Indigenous organizations, including First Nations, Inuit and Métis organizations.

This may explain why suddenly universities and colleges are 'requiring' students to be vaccinated.\*

#### OFFICIAL DEATH STATS ALSO INCLUDE NON-COVID DEATHS

The COVID-19 death certification instructions include mention of the possibility that death was influenced by COVID-19, but caused by another disease or an unintentional injury.\*
